





GDP in USD Billions




Total Population of the GCC Countries (Millions)*





Average Daily Oil Production of the GCC Countries




Stock Market Capitalization of the GCC Countries







Contribution of Oil and Non-Oil Sectors to GDP




Contribution to Bahrain GDP by Main Activities, 2019 (%)



Annual Change in CPI (%)




Money Supply (M2)





Contribution of Oil and Non-Oil Sectors to GDP




Contribution to Kuwait GDP by Main Activities, 2019 (%)









Contribution of Oil and Non-Oil Sectors to GDP




Contribution to Oman GDP by Main Activities, 2019 (%)













Contribution of Oil and Non-Oil Sectors to GDP




Contribution to Qatar GDP by Main Activities, 2019 (%)



Annual Change in CPI (%)




Money Supply (M2)







Annual Change in CPI (%)




Money Supply (M2)









Contribution of Oil and Non-Oil Sectors to GDP




Contribution to UAE GDP By Main Activities, 2019 (%)



Annual Change in CPI (%)




Money Supply (M2)


